

Contract for Driver's Education
Grayson Community School, Gwinnett County

Appointments with the Dept. of Driver Services should not be made prior to receiving your certificate.
The classroom portion will be held at Grayson High School, 50 Hope Hollow Road, Grayson, GA 30052

REQUIREMENTS

- **A copy of the student's learner's permit must be submitted with payment.** Completed contracts & student records must be signed by the student AND parent and returned to the Grayson Community School.

The cost of the Driver's Education 6-hours Behind the Wheel Instruction at Grayson Community School, part of the Gwinnett County School System, is \$280. This fee includes the 6 hours of road instruction. **Students are encouraged to have 15-20 hrs of driving experience before working with our instructors behind the wheel.** Each student will receive a certificate at the completion of the 6-hours behind the wheel instruction. Additional road instruction can be arranged for a fee of \$45 per hour. Certificate Replacement -- \$5.00.

It is the responsibility of the parents to provide transportation for the student to and from the Driver's Education classes and driving appointments located at Grayson Community School, 50 Hope Hollow Rd, Loganville, GA 30052. The telephone number is 770-554-1073. The completion of the course does not in any way, directly or indirectly, imply that the student will receive his/her driver's license from the State of Georgia or any other state.

Notification of cancellation must be received within 2 business days prior to the start of the class. No refunds are given once instruction has begun. If the student fails to appear for a pre-scheduled driving appointment, a fee of \$30 will be charged. This fee must be paid before the student is rescheduled. The student and the instructor will schedule (3) 2-hour sessions to complete the driving portion unless other arrangements have been made.

The Community School's liability insurance follows the car and provides the maximum coverage possible (\$500,000/person/accident/property). Parents and/or guardians of students are not permitted, by DDS mandate, to accompany their student during his/her 6 hours of road instruction. Each instructor is certified by the DDS. Grayson Community School is licensed by the DDS in accordance with Title 43-13-1. A performance bond of \$10,000 has and will be maintained for the protection of the contractual rights of the students.
