Accountability and flexibility are hallmarks of Gwinnett County Public Schools' success. Key to that success is ensuring that each school community understands the progress being made by its schools, as well as what plans will drive improvement. Each school creates a collaborative Local School Plan for Improvement (LSPI), with targeted goals based on student achievement results. These goals are dynamic, like our schools, and are updated to reflect changes that occur in schools. Data is used to determine areas needing improvement and to identify specific, measurable, annual objectives. Schools then determine how to use research-based strategies to achieve these goals, using flexibility as needed. The LSPI development process involves teachers, parents, and community members, so the entire school community has the opportunity to be involved in conversations about school improvement. - **Long Term Goal**

We will build our parents' capacity to support their children's academic achievement by implementing the activities identified in The Plan/The Promise.

- **Long Term Goal**

Jordan Middle School will increase the percentage of students scoring in the “proficient” or “distinguished” range on the Georgia Milestones Assessment for English/Language Arts and Mathematics to 100% in 2024-2025.

- o **Annual Goal**

Jordan Middle School will increase student performance on the Georgia Milestones Assessments (GMAS) in both the End of Grade (EOG) and End of Course (EOC) in all assessed subject areas. Each assessed subject area will increase the number of students performing in the proficient and distinguished level as identified: 6th LA 48%, 7th LA 35 %, 8th LA 45%; 6th MA 42%, 7th MA 43%, 8th MA and Algebra I 40%; 8th SS 40% and 8/9 Phy Sci 35%. For the non-GMAS subjects, we will increase student performance in the proficient and developing range on the district assessments as identified: 6th and 7th SS 40% and 6th and 7th SC 35% which is aligned with the EOG/EOC targets for these subjects. If the above assessments are not available, identified assessments will be utilized to determine progress toward goal.

- o **Annual Goal**

Jordan Middle School will increase our CCRPI score from 2018-2019 by 3% or score in the top 25% of Georgia middle schools in 2020-2021 (no data for 2019-2020). If the above assessments are not available, identified assessments will be utilized to determine progress toward goal.

- **Long Term Goal**

Jordan Middle School students will demonstrate mastery in mathematics and science with 100% of students scoring in the “proficient” or “distinguished” range on the Coordinate Algebra I and Physical Science EOC State Assessment in 2024-2025.

- o **Annual Goal**

Jordan Middle School will have all of the students (100%) enrolled in Algebra I, Accelerated Algebra I, and 9th Grade Physical Science score in the developing, proficient, and distinguished range (Post 1 and Post 2). By May 2021, at least 40% of all the students enrolled will score proficient and distinguished range on the EOC Algebra I and EOC Physical Science. If the above assessments are not available, identified assessments will be utilized to determine progress toward goal.
